

Scott Credit Union Snowball Your Savings Special Official Contest Rules

1. **NO PURCHASE IS NECESSARY TO ENTER OR TO WIN.** This contest is open to current legal U.S. residents and is void where prohibited by law. Employees, board members and associates of Scott Credit Union and their household family members are not eligible.
2. **HOW TO ENTER:** From December 1, 2018 through December 31, 2018, when a participant opens a youth savings account at Scott Credit Union with a minimum deposit of \$5.00, they will receive one entry. OR, entrant may handwrite, "Snowball Your Savings Contest Entry", his/her name, address, and daytime phone number on a 3" x 5" card and mail it in an envelope to: SCU Marketing, 101 Credit Union Way, Edwardsville, IL 62025. Mail-in entries must be received by 6:00 p.m. on January 2, 2019, to be eligible for the drawing. Each mail-in entry must be individually hand printed and mailed separately. Mass entries or mechanically reproduced entries will not be accepted. Scott Credit Union is not responsible for incomplete, lost, late, illegible, or stolen entries. All entries become the exclusive property of Scott Credit Union and will not be acknowledged or returned. By entering this contest, entrants accept and agree to be bound by these Official Rules and the decisions of the judges, which shall be final, binding and conclusive in all matters.
3. **PRIZE:** The Grand Prize winner will have his/her minor savings account balance matched, effective January 1, 2019 up to \$500. If Grand Prize winner is not a Scott Credit Union account holder, he/she will be required to present evidence of savings balance at his/her financial institution effective January 1, 2019 to receive savings match up to \$500.
4. **ODDS:** Odds of winning depend on the number of eligible entries received. Winners of the prizes will be drawn from the pool of entrants that participated.
5. **CONTEST SCHEDULE:** The contest will begin Saturday, December 1, 2018, and will end on Monday, December 31, 2018 at 11:59 p.m.
6. **DRAWING:** The winner will be randomly selected from the pool of entries. The winner will be announced by January 31, 2019 via the Scott Credit Union Facebook page. Scott Credit Union reserves the right to disqualify any entry suspected of fraudulent activity. Prize will be awarded within 30 days after the winner is announced.
