

**Scott Credit Union International Credit Union Day 2021
Official Sweepstakes Rules**

1. This sweepstakes is a savings promotion raffle open to current legal U.S. residents 18 years of age or older who are current Scott Credit Union members in good standing. This sweepstakes is void where prohibited by law. Employees, board members and associates of Scott Credit Union and their household family members are not eligible.
2. **HOW TO ENTER:** Scott Credit Union members visiting a Scott Credit Union branch in the St. Louis – Metro East area will have the opportunity to enter via a digital form completed and submitted by a Scott Credit Union employee. One entry per person per day may be obtained in this manner. Entries must be submitted by October 21, 2021. Scott Credit Union is not responsible for incomplete, lost, late, or incorrect entries. All entries become the exclusive property of Scott Credit Union and will not be acknowledged or returned. By entering this sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of the judges, which shall be final, binding and conclusive in all matters.
3. **PRIZE:** One grand prize winner will receive four Fox Club tickets and a parking pass to see *Pretty Woman* at The Fabulous Fox Theatre on November 18, 2021 (approximate value \$350). Scott Credit Union reserves the right to substitute a prize of equal or greater value based on availability. Prize is subject to applicable terms and conditions.
4. **ODDS:** Odds of winning depend on the number of eligible entries received. The winner of the prize will be randomly drawn from the pool of entrants that participated. Each eligible entry in this savings promotion raffle has an equal chance of being drawn.
