

## **Scott Credit Union Small Business Saturday Official Contest Rules**

1. **NO PURCHASE IS NECESSARY TO ENTER OR TO WIN.** This contest is open to current legal U.S. residents 18 years of age or older and is void where prohibited by law. Employees, board members and associates of Scott Credit Union and their household family members are not eligible.

3. **HOW TO ENTER:** Any person who visits the Scott Credit Union Facebook page and leaves a comment on SCU's Small Business Saturday post (published November 17, 2021) between November 17, 2021 and November 23, 2021 with the name of a small business is entered to win. One entry per person may be obtained in this manner. Comments that are vulgar, abusive, or offensive to the general public may be subject to deletion and are ineligible for the contest. Scott Credit Union is not responsible for lost, late, or deleted entries. By entering this contest, entrants accept and agree to be bound by these Official Rules and the decisions of the judges, which shall be final, binding and conclusive in all matters.
